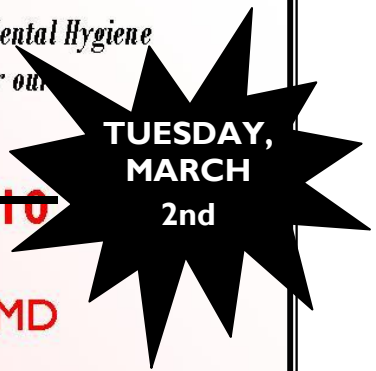

FROM I-95 SOUTH (WASHINGTON):

Take I-95 north to Baltimore. Follow the signs for Martin Luther King Jr. Blvd. Turn right onto Pratt Street. Turn left onto Penn Street (the first traffic light). The parking garage is on your left.

FROM I-95 NORTH (NEW YORK):

Take I-95 to Baltimore. Follow signs for I-395 Baltimore. Once on I-395 follow signs for Martin Luther King Jr. Blvd. Turn right onto Pratt Street. Turn left onto Penn Street (the first traffic light). The parking garage is on your left.

FROM BWI AIRPORT:

Take Baltimore-Washington Parkway north to Baltimore. Follow parkway to end; it will turn into Paca Street. Turn left onto Lombard Street. Turn left onto Penn Street (the second traffic light). The parking garage is on your right.

FROM I-83 SOUTH (PENNSYLVANIA):

Take I-83 south to Baltimore. Continue to end of the interstate and go to third traffic light. Turn right onto Lombard Street. Take Lombard Street west to Penn Street. Turn left onto Penn Street (the first traffic light past Greene Street/University Hospital). The parking garage is on your right.

Parking is available in the Penn Street Garage at Penn and Pratt Streets.
