## MEMORANDA.

Sessions—The Sessions will be held from 12 M. to 3 P. M. and from 8 P. M. to 10.30 P. M.

On *Wednesday night* will be held the *Executive Session*, at which all reports of officers and committees will be made. Unfinished Business and New Business will be considered. Amendments may be offered, and those on file will be acted upon. The *election* of all *officers* will take place at this session.

On *Thursday night* the annual *oration* will be delivered by Prof. REGINALD H. FITZ, M. D., of Harvard University, on "*Intra-Peritoneal Hemorrhage*." This will be followed by the annual *banquet*, which will be given in the Hall of the Faculty. Tickets, \$2.00, may be obtained from the Committee—*Dr. Ashby*, Chairman. Members and delegates *from the counties* will be the guests of the Faculty.

The election of candidates to *membership* may take place at the conclusion of the reading of any paper *after the first day*—provided the names have been posted on the *bulletin board* the day previous. Blank applications may be secured at the officers' tables. The *initiation fee* is \$5.00.

As the titles of all the papers printed in this programme were sent to the Secretary in time to be grouped in their proper places they will *take precedence* over those offered at the opening or during the sessions.

Should the list of papers, at any session, be exhausted, before the time of adjournment, papers announced for the session following may be called up.

The author of each paper is requested to hand to the Recording Secretary the original manuscript or a type written copy of his paper as soon as it shall have been read. Papers should be in the possession of the Recording Secretary within one week after the close of the convention to insure their publication in the TRANSACTIONS.

Papers may either be read entire, by abstract, or by title only, as may be determined by the Faculty at the instance of the author. Every paper read before the Faculty shall be submitted for discussion, and no member shall be privileged to occupy more than *five minutes* in the discussion thereof; and further the general discussion of a paper shall be limited to *thirty minutes*, unless otherwise ordered by vote of the Faculty.

MEMBERSHIP. Applications for membership in the Medical and Chirurgical Faculty should be addressed to the Recording Secretary, Corresponding Secretary or Treasurer, and should state name in full, post office address, where graduated in medicine, date of graduation, and by whom recommended. ## Medical & Chirurgical Faculty of Maryland,

Is permanently located at the Hall of the Faculty,

N. W. Cor. St. Paul and Saratoga Streets.

The Committee in charge is using every effort to make it a success, by securing the registration of competent nurses, by bringing the matter constantly to the notice of the profession and of the public, and by paying prompt attention to all calls for nurses. It is earnestly hoped that the members of the Faculty will take an interest in this institution, which is so greatly needed by themselves and their patients. They may do this by sending to the Directory the names and addresses of reliable nurses, and by referring patients who desire nurses to the Directory.

The Committee has been gratified by the decidedly increased demand on the part of physicians and the public for that much desired class, hospital trained nurses, of which there has been an addition of 25 per cent. to the rolls during the past year. The standard of nursing has thereby been considerably raised.

Special attention is called to the fact that the Directory has an excellent telephone connection.

The Directory furnishes promptly for city or country, in all cases of sickness or accident, male and female nurses skilled in all branches of nursing, including massage. Wet-nurses, who have been examined by the Committee are also provided. Nurses may be procured by telegraph; in this case a statement should be given of the nature of the sickness, the address of the applicant, and the price he is willing to pay. All fees must be paid in advance, including price of ticket, to applicant's address.
